1. General description

Bidirectional ElectroStatic Discharge (ESD) protection diode in a very small SOD323 (SC-76) SMD plastic package designed to protect one signal line from the damage caused by ESD and other transients.

2. Features and benefits

- Bidirectional ESD protection of one line
- Max. peak pulse power: $P_{PPM} = 200\text{ W}$
- Low clamping voltage: $V_{(CL)R} = 70\text{ V}$
- Ultra low leakage current: $I_{RM} < 1\text{ nA}$
- ESD protection $> 23\text{ kV}$
- IEC 61000-4-2, level 4 (ESD)
- IEC 61000-4-5 (surge); $I_{PPM} = 3\text{ A}$
- Very small SMD plastic package
- Qualified according to AEC-Q101 and recommended for use in automotive applications

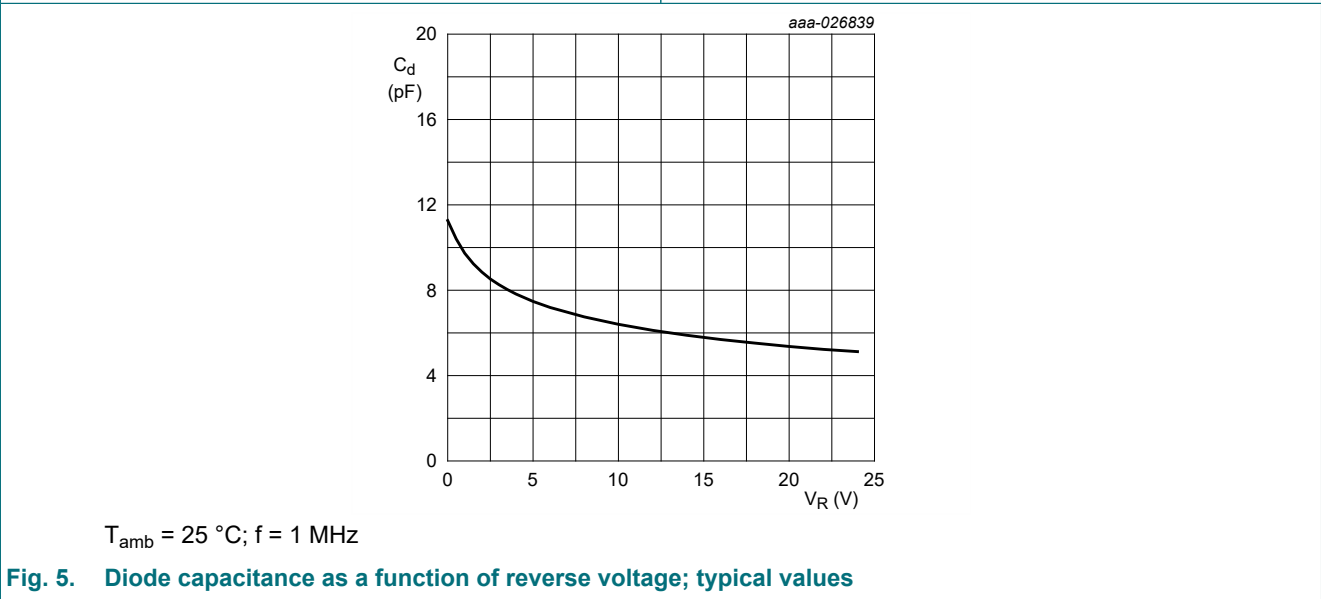

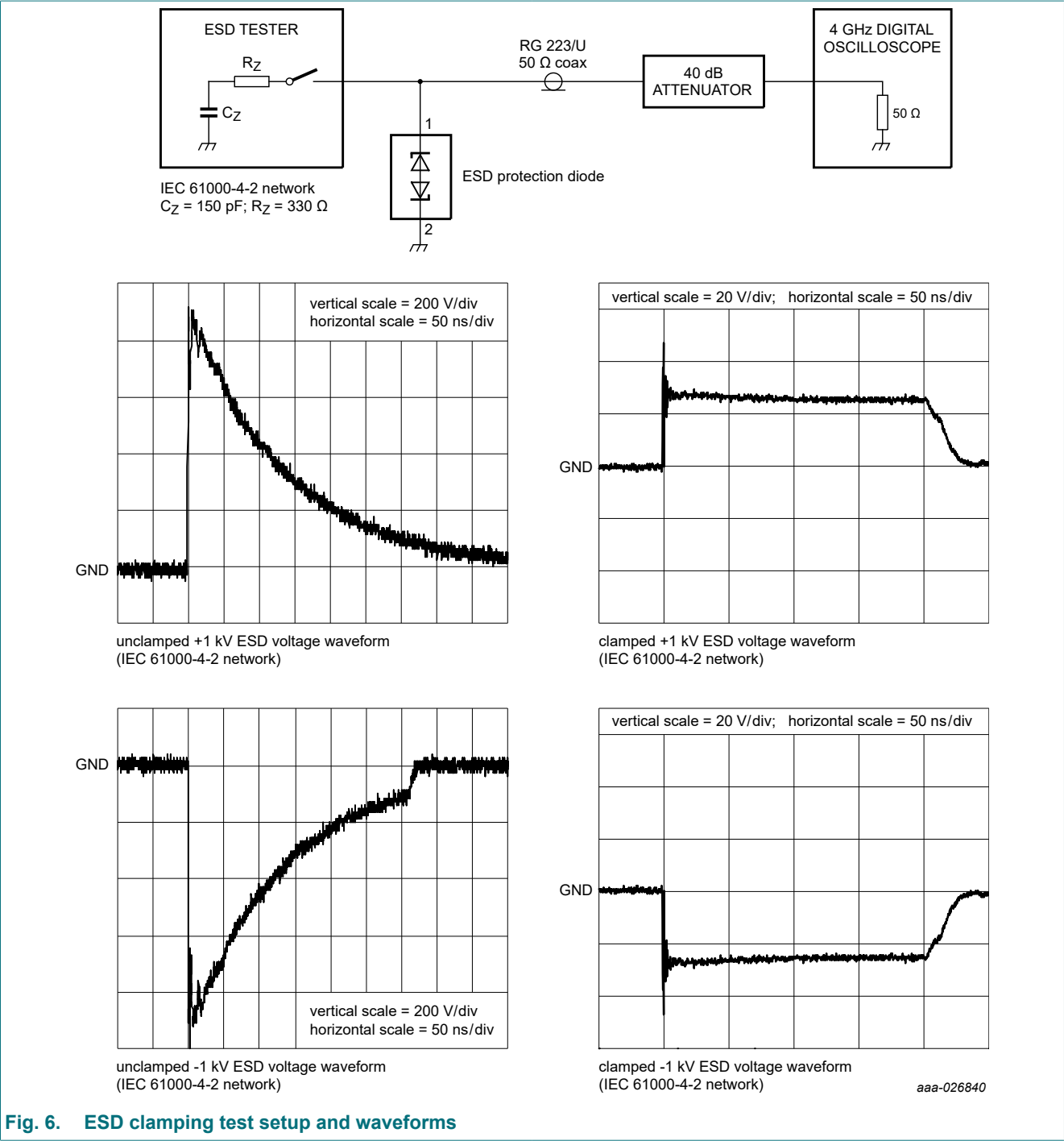


Fig. 6. ESD clamping test setup and waveforms

10. Application information

The device is designed for the protection of one bidirectional data line from surge pulses and ESD damage. The device is suitable on lines where the signal polarities are both positive and negative with respect to ground. The device is not designed to be used on lines connected to a DC supply.

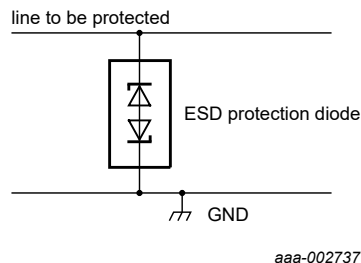


Fig. 7. Application diagram

Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

Quality information

This product has been qualified in accordance with the Automotive Electronics Council (AEC) standard Q101 - *Stress test qualification for discrete semiconductors*, and is suitable for use in automotive applications.

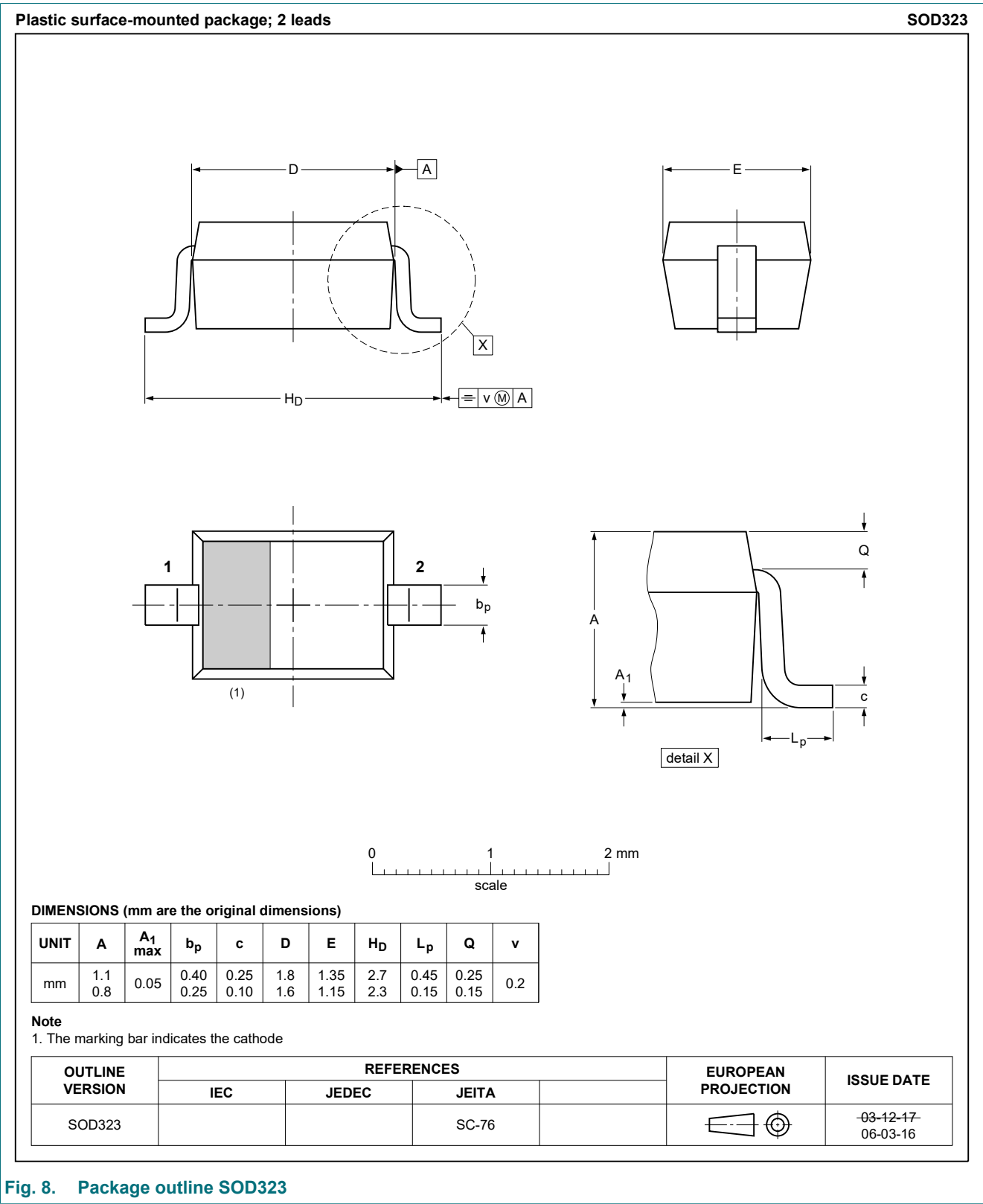


Fig. 8. Package outline SOD323

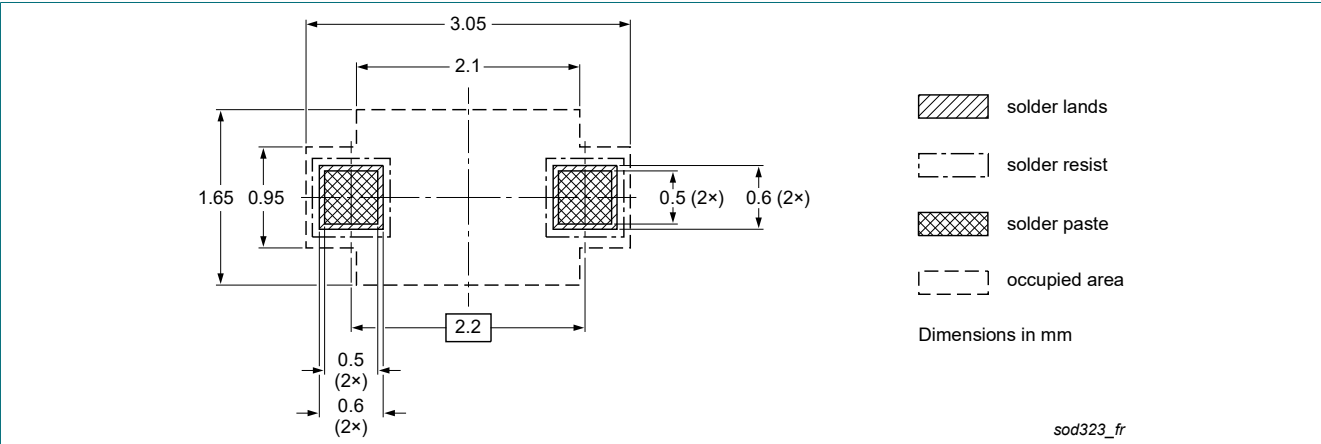


Fig. 9. Reflow soldering footprint for SOD323

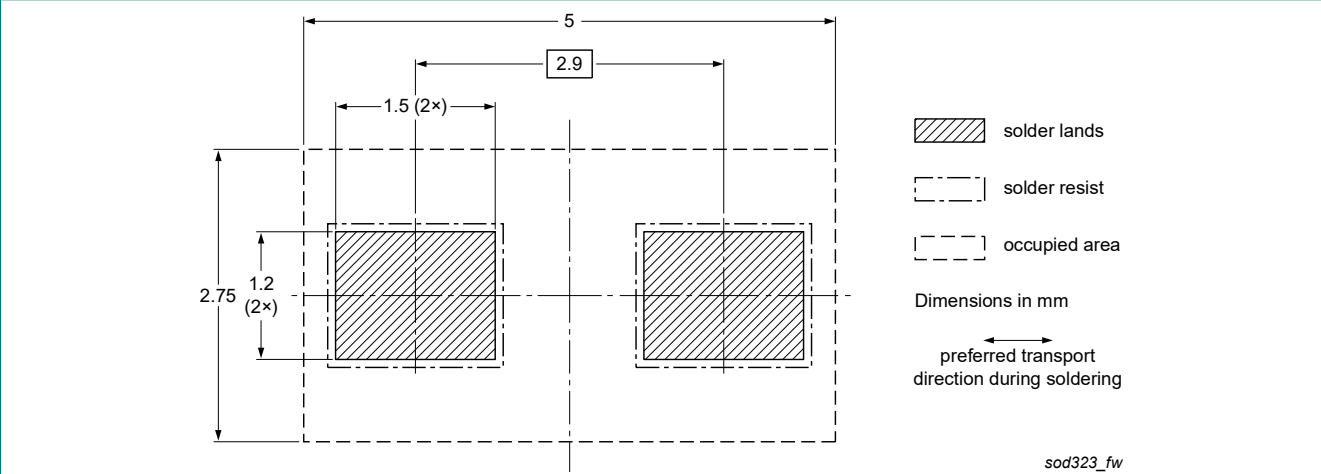


Fig. 10. Wave soldering footprint for SOD323
